Collections Report – No delinquencies.

Citations – Lot 118 was cited \$50 for a white line violation. Lot 208 was cited \$100 for two unauthorized vehicles parked on someone else's vacant lot.

Ms. Ward moved to approve the November Balance Sheet; Ms. Lancaster seconded the motion and the motion carried unanimously. Ms. Lancaster moved to approve the November Profit & Loss; Mr. Baker seconded the motion and the motion carried unanimously.

GENERAL MANAGER'S REPORT

Mr. Shubin moved to approve the November General Manager's Report; Mr. Coon seconded the motion. Raccoons and wild cats, particularly on Yaqui Loop, were discussed. Ms. Wilson said she talked to a woman on Yaqui who has been feeding the animals. She stopped feeding

them for awhile, but she started feeding them again because they growl. Mr. Sweeney said he tried to trap them at a vacant lot, but the traps were sprung with no animals caught. Mr. Kaufman said he puts dry cat food in the traps, then catches them and releases them into the wild. The raccoons eat there every day; Mr. Kaufman said it would be okay to put traps on the north side of his property. Mr. Sweeney said these animals are mean. Ms. Wilson said animal control told her that anyone who feeds wild animals more than five days essentially owns the animals. Mr. Sweeney said he will set more traps, but we can't stop the woman from feeding them, and it isn't easy catching them and releasing them into the wild. Ms. Ward asked if we can impose a fine for feeding wild animals. Ms. Wilson said she would call animal control again. Mr. Baker said these animals pose a health issue. Mr. Sweeney said we can send a letter about violating county regulations. Mr. Kaufman said there are about 7-8 animals now, when there were about 10-15 before. There being no further discussion the motion carried unanimously.

COMMITTEE REPORT ON RENTAL ISSUES

The matter was tabled again.

OLD BUSINESS

Buoy - Mr. Sweeney said he would replace the buoy light at the north entrance this week.

Bridge – Ms. Wilson said the bridge accident reports are in and she is presenting a claim to court, which she said is all we need to do.

Trash Enclosures – A bid was received from Cobra One and came in \$213 less than Larry's Painting for \$1,708 to repaint the trash enclosures and repair the shed. The Cobra bid, however, did not include repairs to the shed, but it was otherwise the same as Larry's bid. Mr. Sweeney believes that the cost to repair the shed is probably more than \$200. Mr. Baker made a motion to accept Larry's Painting bid for \$1,708 to repaint the trash enclosures and repair/replace plywood in the tool shed. Mr. Coon seconded the motion and the motion carried unanimously.

Street Cleaning – Ms. Wilson said she talked to King Clapperton and that Squeak had mentioned it to him as well, but Ms. Wilson said she doesn't know the outcome. Mr. Baker said that if the County cleans our streets, they will have to do it for others. Ms. Wilson said we may have to pay the County for the service. Mr. Baker said our streets are private and that is why the County does not want to do it. Mr. Sweeney asked that someone figure out how we can get it done.

NEW BUSINESS

Ms. Wilson asked about hiring security for the Christmas/New Year holidays, and the Board said it wouldn't be necessary since the holidays are on Wednesday.

Ms. Furnell asked about when we should be contacting owners about tree clean up. One of her neighbor's palm trees is dropping berries. APS was recently doing tree clean up in the area, but it was only in regard to clearing paths for their lines. Ms. Wilson said we need to contact the homeowner to request a cleanup. Mr. Croteau's neighbor across the canal next to the Ward's also needs cleanup.

Mr. Baker reported men with bows and arrows shooting at carp off the bridge next to his property. He wondered if we need a rule prohibiting this. Mr. Shubin said he called Fish & Game and was told that they responded to another similar incident where they issued citations and confiscated spears. Mr. Sweeney said we have "No Fishing" signs on the bridges and we should be reporting these incidents to Fish & Game. Mr. Chambers said we should call the Sheriff's Office, and Ms. Ward said witnesses need to take photos.

Mr. Baker said it appears the new owner of Lot 82 is combining houses with the neighbor, and one house is completely gutted. Mr. Sweeney said they would need approval if they changed outside walls, and they would need to submit a security deposit with their plans. Ms. Wilson said concrete is being jack hammered out, and Mr. Coon said that relates to just a driveway. Mr. Svider said they are putting in a common entryway between the two houses. Mr. Sweeney said if they are cutting windows, they need to submit a plan and a deposit. Mr. Coon said they are keeping it clean. They will be asked to submit a plan and a construction deposit.

Mr. Chambers said the metal plate is being fixed on Yaqui Loop in regard to the recent water leak. Ms. Wilson said Brooke Utilities wasn't responding to her reports of the leak, and she talked to them today, but the supervisor still hadn't called her back. Mr. Sweeney said the water line was fixed but the street needs to dry out before the rest of the repairs can be made.
